1. Name. The name of the company is 2 GEMINI, LLC (the "Company").
2. Articles of Organization. The date of the filing of the Articles of Organization of the Company was February 23, 2015 (~~Document Number L14000191081~~) which were filed in connection with a conversion which converted 2 Gemini, Inc. into 2 Gemini, LLC, with an original formation date of February 10, 2003.
3. Amendment. The Articles of Organization of the Company are hereby amended as follows:

Article I is deleted and a new Article I is inserted in lieu thereof, to read as follows:

ARTICLE I
