**ARTICLES OF ORGANIZATION

The undersigned, Kevin Logan, a natural person competent to contract and an authorized representative of a member of Ajax Property Investments, LLC, hereby presents these Articles of Organization as the Articles of Organization of Ajax Property Investments, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Ajax Property Investments, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

**ARTICLE VI - MANAGEMENT**


The Company shall be managed by a manager in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial manager of the Company is as follows:


