**ARTICLES OF ORGANIZATION
OF
ACJIT, LLC**

The undersigned, Charles R. Shanklin, a natural person competent to contract and an authorized representative of Bernice R. Shanklin, the sole member of ACJIT, LLC, hereby presents these Articles of Organization as the Articles of Organization of ACJIT, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is ACJIT, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE VI - MANAGEMENT

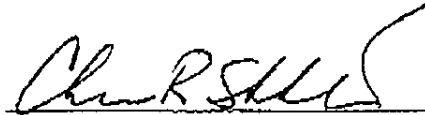
The Company shall be a manager-managed limited liability company and will be managed in accordance with the terms of the Operating Agreement for the Company.
