**ARTICLES OF ORGANIZATION  
OF  
SUNSHINE SUPPLEMENTS, LLC**

1. Name. The name of this limited liability company is **SUNSHINE SUPPLEMENTS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is **51 E. Jefferson St., #2369, Orlando, Florida 32802.**
