AMENDED AND RESTATED ARTICLES OF ORGANIZATION

RBAK ENTERPRISES, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Rbak Enterprises, LLC, a Florida limited liability company, originally filed on February 23, 2015, are hereby amended and restated in their entirety to read as follows:

ARTICLE I — NAME:

The name of the limited liability company is Rbak Enterprises, LLC (the "Company").

ARTICLE II — PRINCIPAL OFFICE AND MAILING ADDRESS:

The location of the Company's principal office and the mailing address of the Company is 209 14th Street NE, Apt. 107, Atlanta, Georgia 30309.

ARTICLE III — COMMENCEMENT OF EXISTENCE:

The Company shall exist perpetually. The existence of the Company commenced on February 23, 2015, upon the filing of Articles of Organization with the Florida Department of State, Division of Corporations.

ARTICLE IV — REGISTERED AGENT AND OFFICE:

Pursuant to Section 605.04074, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

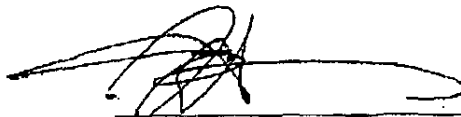
