ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF

- 4. Article IV of the Articles of Organization is hereby amended and restated to read as follows:

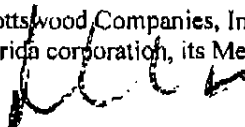
