**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION  
OF  
MONSTER AVIATION, LLC**

The undersigned, being the sole member of MONSTER AVIATION, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company originally filed March 2, 2015, pursuant to the terms of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), states as follows:

1. The name of the Company is MONSTER AVIATION, LLC.
2. The date of the filing of the original Articles of Organization of the Company (the "Articles of Organization") was March 2, 2015 and the Florida Department of State issued the Company Document Number L15000038472.

3. Article II of the Articles of Organization is hereby amended and restated as follows:

**"ARTICLE II**

Principal Office

The mailing address and street address of the principal office of the Company is 259 Meeting Place, Orlando, Florida 32814, or such other place as the manager of the Company may determine from time to time."

4. Article IV of the Articles of Organization is hereby amended and restated as follows:

**"ARTICLE IV**

Management

"The Company shall be manager-managed for the purposes of Section 605.0407 and other relevant provisions of the Act. The name and address of the initial Manager of the Company is:

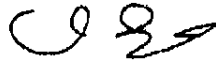
5. The first paragraph of Article V of the Articles of Organization is hereby amended and restated as follows:

**"ARTICLE V**

Transfer of Membership Interests

"If the Company has elected Subchapter S status pursuant to the Internal Revenue Code of the United States in effect from time to time, then transfers of the Company's membership interests made not in accordance with such agreement, whether by operation of law or otherwise, are null and void ab initio, unless the Manager otherwise agrees or determines."
