**ARTICLES OF ORGANIZATION
OF
DANAE'S REJUVENATING SPA, LLC**

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I
NAME & ADDRESS**

The name of this limited liability company is DANAE'S REJUVENATING SPA, LLC (the "Company") and its principal office and mailing address is 415 3rd Street South, Suite 212, St. Petersburg, Florida 33701.

**ARTICLE II
EFFECTIVE DATE**

OPERATING AGREEMENT




