The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **TRUSTLOVEINVEST LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 3817 Lakeshore Drive, Tampa, Florida 33604 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4 - DURATION

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE 5 - PURPOSES AND POWERS


ARTICLE 10 - PROHIBITIONS

The Company shall not invest or issue securities pursuant to an investment contract. In the preceding sentence, "investment contract" shall mean an agreement in which members of the Company invest and expect to make a profit from the entrepreneurial and managerial efforts of others or any other meaning pursuant to the federal Securities Act of 1933, Investment Company Act of 1940 or regulations promulgated thereunder by the U. S. Securities and Exchange Commission. The Company shall not make, nor propose to make, a public offering of its securities or have more than one hundred Members of the Company. The Company shall not own or hold investment securities valued at forty percent of the value of its assets. In the preceding sentence, "Investment securities" shall mean all securities except government securities, securities issued by employees' securities and securities issued by majority-owned subsidiaries of the owner which are not investment companies and are not relying on the exception from the definition of investment company as described in paragraph (1) or (7) of subsection (c) of Section 3(a)(10)(C) of the Investment Company Act of 1940 or regulations promulgated thereunder by the U. S. Securities and Exchange Commission. The Company shall not authorize a prohibited transaction between the Company and a disqualified person, as such terms are defined in Section 4975 of the Internal Revenue Code or regulations promulgated thereunder by the Internal Revenue Service.


