## ARTICLES OF ORGANIZATION

# A Florida Limited Liability Company (FS Section 605)

The undersigned, hereby certify that we have associated ourselves together for the purpose of forming a limited liability Company under the laws of the State of Florida pursuant to Fla. Stat. 605 entitled the Florida Limited Liability Company Act. providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We do hereby adopt the following Articles as the Charter and authority for the conduct of business of such limited liability company.

## ARTICLE I

## NAME

## ARTICLE III

## RESTRICTIONS ON MEMBERSHIP
