Article I of the Articles of Organization of the Company shall be amended as follows:

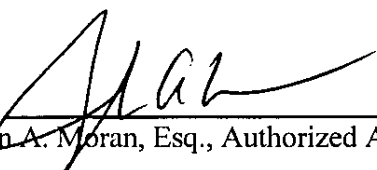
