The name of the limited liability company is Bird's Eye Healthcare, LLC.

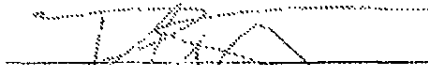
ARTICLE II. ADDRESS

The mailing and street address of the principal office of the limited liability company is 220 2nd Avenue SW, Largo, FL 33770.

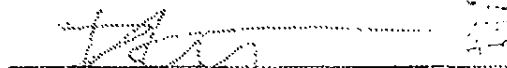
ARTICLE III. REGISTERED AGENT AND OFFICE
