**ARTICLES OF ORGANIZATION  
OF  
S2G LATAM HOLDINGS LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

**ARTICLE I. NAME**

The name of the limited liability company is S2G Latam Holdings LLC (the "Company").

**ARTICLE II. MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be South Florida Logistics, Building 2, 3200 N.W. 67<sup>th</sup> Street, Suite 200, Miami, Florida 33122.
