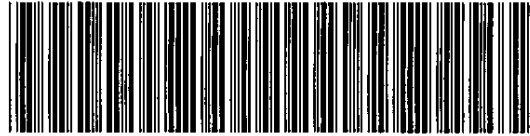




The Articles of Organization for this Limited Liability Company were filed on March 9, 2015 and assigned Florida document number L15000042481.
