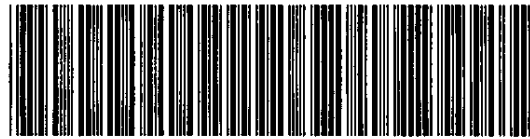

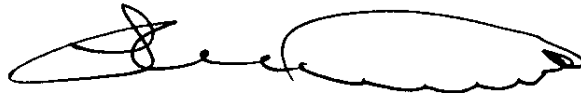

**ARTICLES OF ORGANIZATION OF
OCALA COMMERCE PLAZA LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I – Name:
