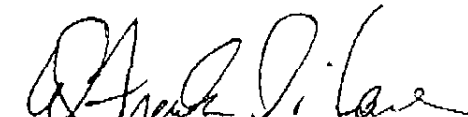
Article VIII

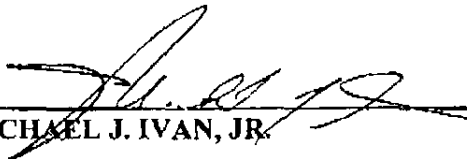
