**ARTICLE I - NAME**

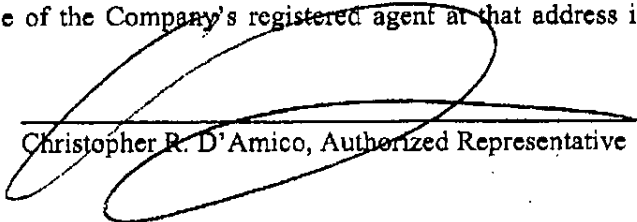
The name of the Limited Liability Company shall be SWAYING PALM BREEZES, LLC (the "Company").
