ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF

NAME

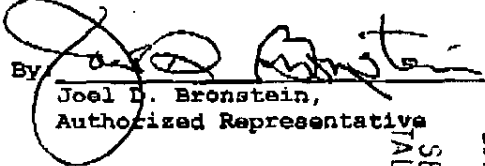
"The name of the Limited Liability Company shall be Mackenally Investments, LLC."
