The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 605 of the Florida Statutes.


**ARTICLE VII - ADOPTION OF OPERATING AGREEMENT**


**ARTICLE VIII - AMENDMENT**
