



These Articles of Organization shall become effective when filed.

#### ARTICLE VI – OTHER PROVISIONS

It is intended that the limited liability company will be owned by an Individual Retirement Account ("IRA") created under the Internal Revenue Code of 1986, as amended (the "Code"). The initial Member of the limited liability company holds all Membership Interests for the benefit of an IRA account holder (the "IRA Account Holder"), as designated in the Operating Agreement of the limited liability company.

Notwithstanding any provision of the Operating Agreement of the limited liability company, the limited liability company is not permitted to and shall not take any action or be authorized to engage in any business that is a "prohibited transaction," as defined by Code section 4975(c)(1), with respect to the IRA Account Holder. Nor shall the Company be permitted to make any investment, engage in any business, or use Company property for any purpose that would cause any Member to lose its tax status as an IRA under Code section 408. It is the intent of the IRA Account Holder, the initial Member(s), and the initial Manager(s) to preserve the tax status of the Member IRA account(s), and all provisions, terms, and conditions contained in governing documents of this limited liability company should be construed to give full force and effect to that intent.
