**ARTICLES OF ORGANIZATION
OF
DAVIA MIAMI CONSULTING LLC**

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is DAVIA MIAMI CONSULTING LLC (the "Company").

ARTICLE II. PRINCIPAL AND MAILING ADDRESS

The principal address of the Company is 2900 N. Ocean Drive, Suite 501, Hollywood, Florida 33019. The mailing address of the Company is 450 SE 7th Street, Suite 240, Dania Beach, Florida 33009.

ARTICLE III. REGISTERED AGENT AND OFFICE

ARTICLE IV. DURATION AND CONTINUATION


