**RESTATEMENT OF
ARTICLES OF ORGANIZATION
OF
SUBARU OF ORLANDO, LLC**

The Articles of Organization of Subaru of Orlando, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on March 17, 2015. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is Subaru of Orlando, LLC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - INITIAL REGISTERED AGENT

The Company is manager-managed. The initial manager of the Company is New River Auto Mall, LLC, a Florida limited liability company.


