Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **SUBARU OF ORLANDO, LLC** hereby adopts the following Articles of Amendment to its Amended and Restated Articles of Organization:

FIRST: The name of the limited liability company is Subaru of Orlando, LLC (the "Company").


