## ARTICLES OF AMENDMENT TO AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF SUBARU OF ORLANDO, LLC

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, SÜBARU OF ORLANDO, LLC hereby adopts the following Articles of Amendment to its Amended and Restated Articles of Organization:
