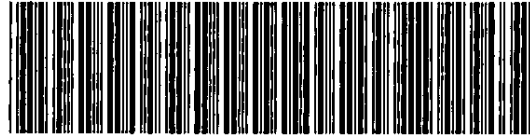

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended from time to time.

**ARTICLE I
Name**

The name of the limited liability company is Together Growing the Game, LLC (hereinafter referred to as the "**Company**").

**ARTICLE II
Address**

Registered Agent**

**ARTICLE IV
Purpose**

The purpose for which this Company is organized is any and all lawful business.

**ARTICLE V
Duration and Continuation**

The period of duration for the Company shall be perpetual, unless terminated in accordance with the Company's Operating Agreement or by unanimous written agreement of all Members of the Company. The remaining Members of the Company shall have the right to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member of the Company in the manner set forth in the Operating Agreement of the Company.

No Member of the Company shall be liable under a decree or order of a court or in any other manner for a debt, obligation or liability of the Company.

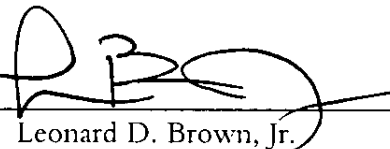
