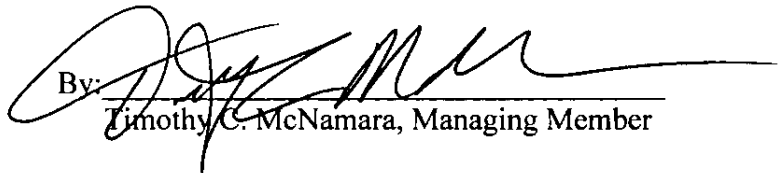

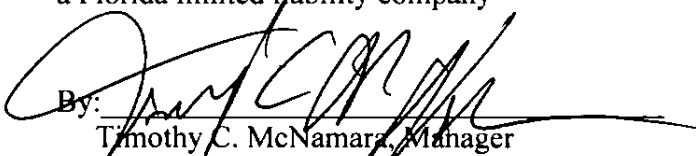
1. The name of the Converting Company immediately prior to the Effective Time (as defined below) is Global Search Associates LLC, a Maryland limited liability company.

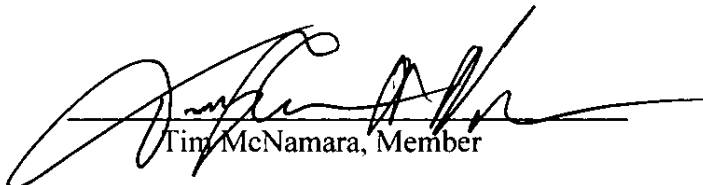
