

ARTICLES OF ORGANIZATION OF LAKE COUNTY COMMERCIAL XV, LLC A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I NAME

The name of this Limited Liability Company shall be LAKE COUNTY COMMERCIAL XV, LLC, and its principal place of business and mailing address shall be located at 7575 Dr. Phillips Boulevard, Suite 245, Orlando, Florida 32801.

ARTICLE II COMMENCEMENT OF EXISTENCE

This Company shall exist for a period of thirty (30) years commencing on the date of filing of these Articles of Organization with the Florida Secretary of State, unless sooner dissolved according to law.

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various Articles shall not be influenced by any of said headings or captions.
