THE UNDERSIGNED hereby executes and swears to this Statement of Correction to Articles of Organization of **D. VOGLER ENTERPRISES, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Revised Limited Liability Company Act, as amended, *Florida Statutes* § 605.0209:

1. Name of Company. The name of the Company is **D. VOGLER ENTERPRISES, LLC**.


b. Paragraph 4 of the Company's Articles incorrectly reflects the mailing and street address of the Company's principal office and is hereby corrected to read as follows:
