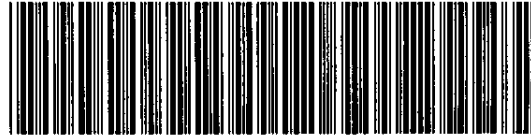

**ARTICLE I**

**Name**

**ARTICLE II**

**Address and Place of Business**
