**RESTATEMENT OF
ARTICLES OF ORGANIZATION
OF

The Articles of Organization of Savannah Motorcars, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on March 23, 2015. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby restated in their entirety to read as follows:

ARTICLE I - NAME

ARTICLE II - PRINCIPAL OFFICE

The mailing address and street address of the Company's principal office is 265 Drivers Way, Hardeeville, South Carolina 29927.


ARTICLE III - INITIAL REGISTERED AGENT
