**ARTICLES OF ORGANIZATION

The undersigned, Louis Lesemann, a natural person competent to contract and a member of Beach Brothers of Florida, LLC, hereby presents these Articles of Organization as the Articles of Organization of Beach Brothers of Florida, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Beach Brothers of Florida, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS


