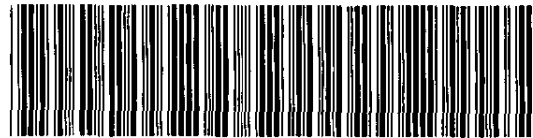


FIRST: ARTICLE V is amended to reflect that JoMed Construction Corp. shall not be a member or manager of the Company effective March 28, 2015.
