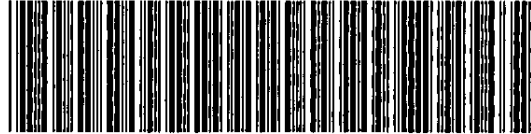



ARTICLES OF ORGANIZATION OF

TPM UNLIMITED, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **TPM UNLIMITED, LLC.**

ARTICLE II - ADDRESS

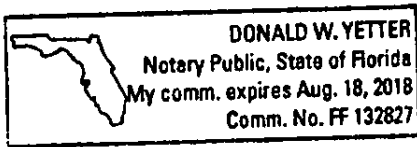
