

Articles of Organization
of
LSR Rental, LLC
A Florida Limited Liability Company


1. **Name.** The name of this limited liability company is LSR Rental, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes.
2. **Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
4. **Place of Business.** The mailing address of the Company is P. O. Box 200, Pineland, Florida 33945 and the street address of the Company's principal office is 13771 Waterfront Drive, Pineland, FL 33945.
5. **Registered Agent and Office.** The name of the initial registered agent of the Company is Bruce D. Green. The street address of the initial registered agent of the Company is 1380 Royal Palm Square Boulevard, Fort Myers, Florida 33919.
6. **Management of the Company.** The Company shall be managed by a manager or managers and is, therefore, a manager-managed company. Robert A. Wells, Jr., Phyllis R. Wells, Robert A. Wells, III and Kenneth Wells shall serve as the initial Managers of the Company.
7. **Operating Agreement.** The members shall have the power to adopt, alter, amend, or repeal an Operating Agreement for the Company containing provisions for the regulation and management of the affairs of the Company.
8. **Voting.** The Company is authorized to issue membership units with voting rights and membership units without voting rights.
9. **Certificated Interests.** The members' interests in the Company may be evidenced by certificates.

The undersigned executed these Articles of Organization effective as of March 20, 2015. In accordance with Section 605.0201, Florida Statutes, the execution of these Articles of Organization constitutes an affirmation under the penalties of perjury that the facts stated herein are true.
