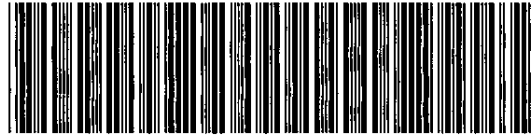

The name of the Limited Liability Company is Forum Capital Partners, LLC."


4. The foregoing amendment shall become effective upon filing with the Department of State of the state of Florida.
