ARTICLE VI – ADMISSION OF NEW MEMBERS

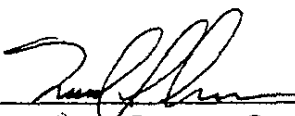

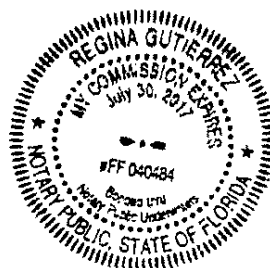

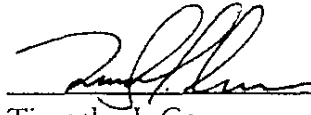
