ARTICLES OF ORGANIZATION
OF
LEVEL YOGA, LLC

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, pursuant to the Florida Revised Limited Liability Company Act (the "Act"), hereby adopt the following Amended and Restated Articles of Organization:

ARTICLE 1
NAME

The name of the Limited Liability Company is LEVEL YOGA, LLC (the "Company").

ARTICLE 2
DURATION

The Company shall exist on the date of filing of these Articles with the Secretary of State of the State of Florida. The duration of the Company shall be perpetual.

ARTICLE 3
NATURE OF BUSINESS

The Company is organized for the purpose of transacting any and all lawful business permitted under the Act.

ARTICLE 4
ADDRESS

AMENDMENT

The company reserves the right to amend or repeal any provision contained in these Amended and Restated Articles of Organization, and any right conferred upon the members is subject to this reservation. Notwithstanding anything contained herein or in the Company's Operating Agreement, these Amended and Restated Articles of Organization may not be amended except upon the prior written consent of the members holding at least two-thirds of the membership interests in the Company.
