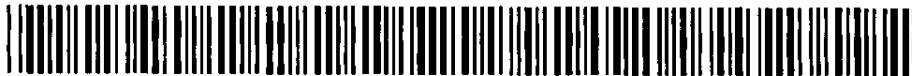

Operating Agreement


