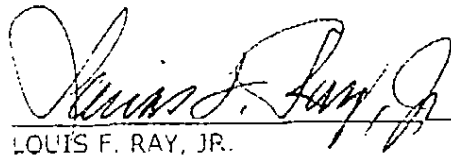
6. All debts, obligations and liabilities of the LLC have been paid or discharged or adequate provision made therefor.

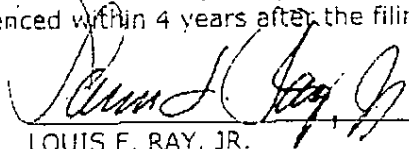
