

Statement of Facts

During March 2023, Mrs. Lindsay Garcia contacted me, Jean Toro about her role as a Register Agent for Vernon Producciones LLC. She requested me a fee for her representation to do the filling of the Annual REport. After comparing the service price against other quotes, I found it pricy so, I informed Mrs. Garcia verbally that her service with Vernon were terminated. Her response was that if we do not pay the requested amount, she will be terminating the company alleging that Vernon Producciones LLC were register with her social security as a register agent. After reviewing our Article of Organization, it was determined that her social security was not included in the document. Vernon Producciones LLC always operated with its own Employer Identification Number 32-0462829. Consequently, we disregarded her threatened allegations thinking that she only was trying to put pressure on us. On March 6th, we filed "2023 Florida Limited Liability Company Annual Report". Unfortunately, the changes for the registered agent were not included, for which on March 9th, 2023, an amended Annual Report was filed. In the mentioned we included the changes for the register agent appointing Mrs. Andrea Gomez to represent Vernon Producciones LLC.

To our surprise on March 11th, Jonathan Toro, manager for the Company went into the website and view that Vernon Producciones LLC was inactive and a "Voluntary Dissolution" was filed by Lindsay Garcia without our consent.

As per the above, we'ld like your consideration on the following:

- 1. Vernon Producciones LLC is register under its own EIN 32-0462829 not Lindsay Garcia Social Security.
- 2. Vernon Producciones LLC inform Mrs. Garcia about her termination as register agent, so we did not act without her knowledge about her termination as Vernon representative.
- 3. The new appointment was register by Vernon Producciones LLC following State of Florida requirements,
- 4. Based on Pursuant to Chapters 605, 607, and 617, F.S., the fact that the department files or refuses to file a document does not create a presumption that the document is valid or invalid or that information contained in the document is correct or incorrect, for this reason we request to revoke the voluntary dissolution since it was not requested by any company's officer nor requested by them and alleging false information.
- 5. Under the below Mrs. Lindsay Garcia does not have the right to dissolve "Vernon Producciones LLC". She granted herself the power to dissolve the company while she is not even an authorized officer in this entity. She stated that Jean Toro did not communicate to

her about the change of as Register Agent, when he did provide the information and she went in his behalf and dissolve the company without authorization.

"It is a third-degree felony for a party to file a fraudulent document on the records of the Florida Department of State. Section 817.155, Florida Statute (F.S.), states,

.....A person may not, in any matter within the jurisdiction of the Department of State, knowingly and willfully falsify or conceal a material fact, make any false, fictitious, or fraudulent statement or representation, or make or use any false document, knowing the same to contain any false, fictitious, or fraudulent statement or entry. A person who violates this section is guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083 or s. 775.084."

6. Finally, we kindly request that Vernon Producciones LLC Voluntary Dissolution get revoked reinstating the company to the Active status.

We thank you in advance for your help in this matter and we hope it can be solved favorable for Vernon Producciones.
