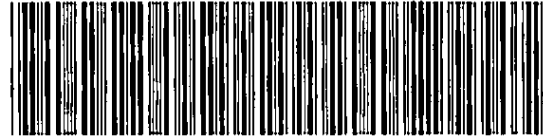


LLC ceased business in Florida January 1, 2018 and submitted a Certificate of Conversion to the State of Texas.
