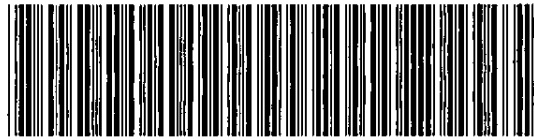

The Company shall be managed by its member and is, therefore, a member-managed Company. The name and address of the managing member of the Company is:


