The undersigned hereby submits these Articles of Organization (these "Articles of Organization") for purposes of forming ASH HOMES, LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Fla. Stat.*

ARTICLE I – Name:


ARTICLE VIII – Amendments:
