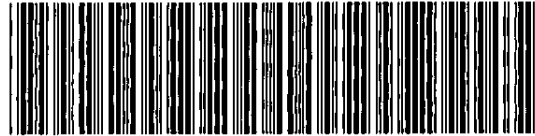

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **SPZ HOMES, LLC** ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 2420 Brixham Avenue, Orlando, Florida 32828 and the mailing address shall be the same.

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

**ARTICLE 4 - DURATION**

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE 5 - PURPOSES AND POWERS**

whose mailing addresses shall be the same as the principal office of the Company.

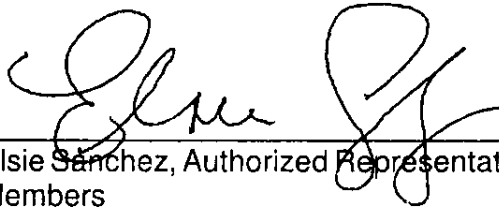

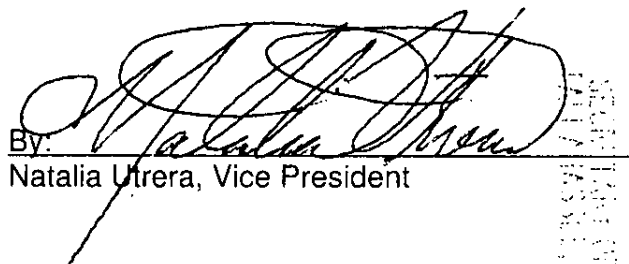
