## ARTICLES OF CONVERSION

Pursuant to the provisions of Section 605.1045 of the Florida Revised Limited Liability Company Act (the "Act"), GREEN BUBBLE SERVICES, LLC, a Virginia limited liability company (the "Converting Entity"), hereby delivers these ARTICLES OF CONVERSION and attached ARTICLES OF ORGANIZATION for the purpose of converting the Converting Entity from a Virginia limited liability company to a Florida limited liability company pursuant to the provisions of Section 13.1-1075 of the Code of Virginia and Section 605.1041(2) of the Act.

1. The name of the Converting Entity immediately prior to the filing of the Articles of Conversion is GREEN BUBBLE SERVICES, LLC.
2. The Converting Entity is a limited liability company first formed under the laws of the State of Virginia on June 18, 2008.

5. The conversion will be effective on the date of filing these Articles of Conversion and the accompanying Articles of Organization with the Florida Department of State.
6. The plan of conversion has been unanimously approved by all of the members of the Converting Entity in accordance with all applicable Florida and Virginia laws, and no member is entitled to appraisal rights under the Act.

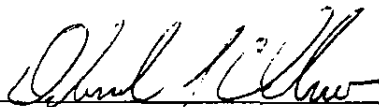
