The undersigned, PHILIP C. DURANT, hereby presents these Articles of Organization as the Articles of Organization of FLIP DURANT, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

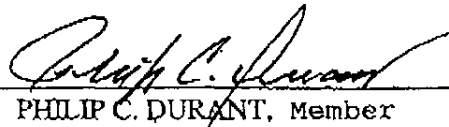
