ARTICLE II. ADDRESS

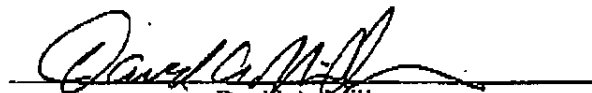

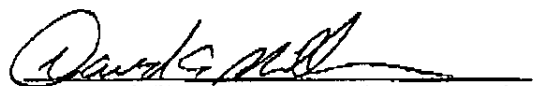
