**ARTICLES OF ORGANIZATION
OF
SIXTEEN HUNDRED SEVENTEENTH, LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is Sixteen Hundred Seventeenth, LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal and mailing address of the Company is 1510 SE 17th Street, Suite 400, Fort Lauderdale, Florida 33316.

**ARTICLE III
