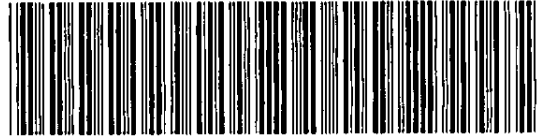

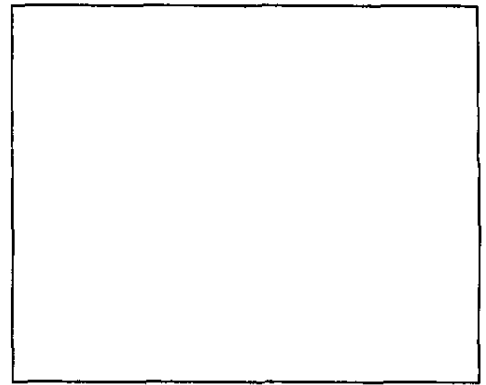

TAMPA LLC, (the "Company").


- b. In all other respects, the Articles of Organization shall remain unchanged.
