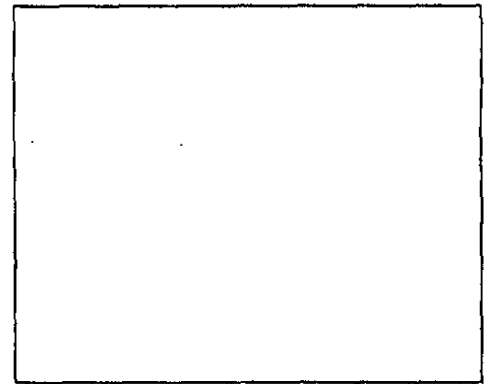

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
POH TAMPA LLC**

The undersigned does hereby execute, acknowledge and file the following Articles of Amendment to the Articles of Organization of POH TAMPA LLC.

1. The name of the Company is currently POH TAMPA LLC.
2. The date of the filing of the Articles of Organization was April 8, 2015 and assigned Document No. L15000062139 which Articles of Organization were amended on April 6, 2016 changing its name to POH TAMPA LLC.
3. The Articles of Organization are amended as follows:
 - a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the following:

**"ARTICLE I
NAME**

The name of the limited liability company shall be POH VERO BEACH LLC, (the "Company").
